- Non-compliance with DOT regulations is not only a safety hazard, consider this: DOT employers are liable to the United States for a civil penalty in an amount not to exceed \$10,000 for each offense.
- A leading national retail store paid \$102,048 in monetary relief for failing to provide reasonable accommodation for applicants or employees in the company's drug testing processes.
- In California, a court ruled that a random drug test administered violated a fundamental right to privacy, which is protected by the California Constitution, and therefore exceeded the risks and expectations inherent in the employment relationship. The Plaintiffs were awarded approximately \$15,000 each for noneconomic damages.

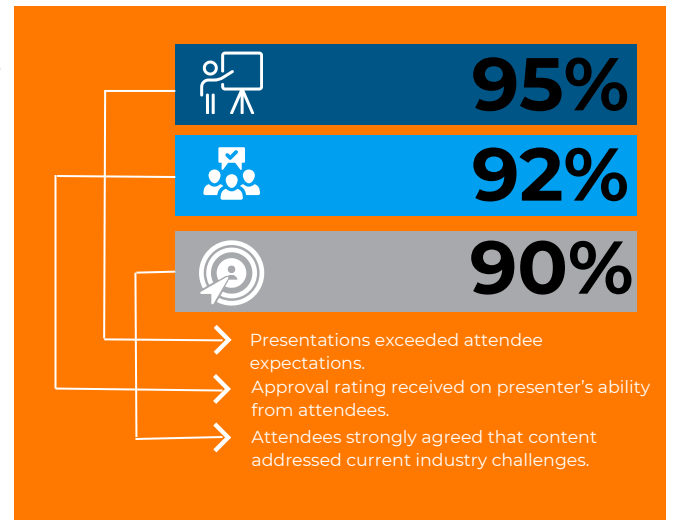
